High Growth Potential

The global robotics market was valued at more than \$80bn in 2022, with forecasts suggesting it could more than triple to \$280bn by 2032.⁽¹⁾



Compelling Economics

The average cost of an industrial robot declined from \$46k in 2010 to just \$27k in 2017 – and is forecast to fall to nearly \$7k by 2030, as the technology matures.⁽²⁾




