

The market price returns are based on the official closing price of an ETF share or, if the official closing price isn't available, the midpoint between the national best bid and national best offer ("NBBO") as of the time of the ETF calculates current NAV per share, and do not represent the returns you would receive if you traded shares at other times. Since the Fund's shares did not trade in the secondary market until several days after the Fund's inception, for the period of inception to the first day of secondary market trading in shares, the NAV of the Fund is used to calculate market returns.
